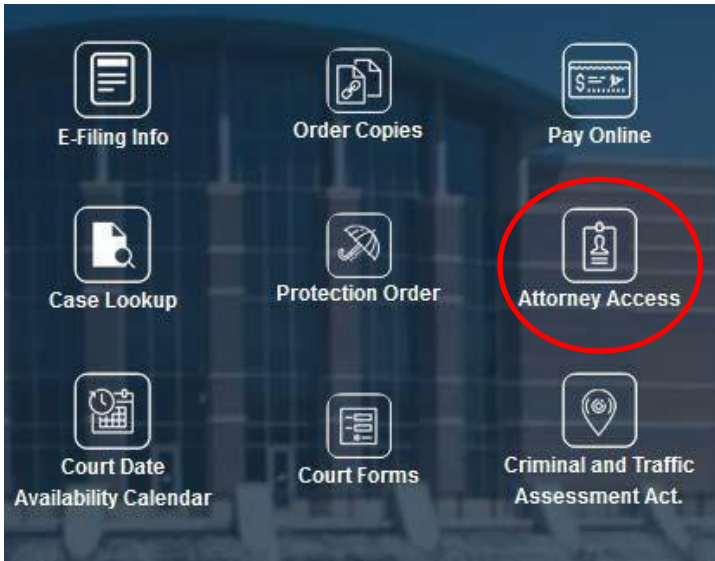

Registration Information

- If you are an attorney, policing agency or self-represented litigant (pro-se) and do not have an active registered account, you must submit a request for access. The request will be reviewed by the 18th Judicial Circuit Clerk's office. Authorization, if granted, is typically available within two business days.
- If you are part of a law firm or policing agency and your firm/agency already has an account, you do not need to register. Your firm should already have a 'Primary Contact' who can define a new User ID.
- If you are requesting a new User ID because your prior one has been inactivated, the new User ID must differ from any previous one.
- Attorneys are able to download their free copies of signed orders within **7 days** of the file date.
